

Application for mandatory breeder identification number (BIN)–dog breeder

About this form

This form is only to be used by a person breeding dogs in NSW to apply for a breeder identification number (BIN) or to activate dog breeder eligibility for an existing BIN.

A breeder identification number (BIN) is issued by the NSW Pet Registry. Use this form if you are unable to create a NSW Pet Registry online account.

No application fee applies.

Please fill out this form in black ink and in BLOCK LETTERS.

Information for dog owners

You are considered a dog breeder in NSW if you own a dog that is pregnant or has a litter, even if this was accidental.

All dog breeders in NSW must have a breeder identification number (BIN) with an active dog breeder eligibility status.

Apply or activate online

The quickest way to apply for a BIN or activate your dog breeder eligibility is to login or create an account on the NSW Pet Registry. Easily view and update your breeder information with an online account.

BIN refusal

Applicants will be refused a BIN if they are subject to a disqualification order or have been convicted of an animal cruelty offence under the *Prevention of Cruelty to Animals Act 1979*.

How to submit this form

1. Present this completed form at your local council office, along with **two** forms of identification.
2. A council officer must check your identification and complete the verification section of this form.
3. Email the completed form to the Office of Local Government at pets@olg.nsw.gov.au

The Office of Local Government will review your application within 20 business days and notify you of the outcome via email. Incomplete applications may result in processing delays.

Accepted proof of identity

You must present **two** forms of identification, including at least **one** form of photo ID. Identification numbers will not be recorded.
